Salient Features : -

1. Applicable Taxes wherever applicable will be charged extra.
2. Administrative & Security Charges of Rs. 750/- per TEU/ per BOE for LCL will be charged to all Import containers.
3. House Keeping Charges of Rs. 1000 for 20 and Rs. 2000 for 40 will be applicable on all Import containers
4. De-stuffing charges of Rs. 2750/- per TEU is applicable to all de-stuffed delivery.
5. Charges for 45 container will be 2.5 times of the 20 container.
6. Shifting charges of INR 1200/- Per TEU for loaded containers for every 30 days' cycle.
7. Charges for ODC containers will be 200 % of normal rate for 20/40 container if ODC rates not agreed separately.
8. Ground Rent for Tank and containers carrying hazardous cargo will be 200 % of the normal loaded charges.
9. Ground rent for F/R / OT carrying ODC will be 200 % in addition to normal loaded charges.

10. For scanning containers CWC weight charges @ Rs. 800/- per TEU will be charged.
11. Documentation Charges: Import containers are liable to pay documentation charges of Rs. 850 for 20 container and Rs. 1100 for 40 containers.
12. All stuffing and de-stuffing operations charges are basis labour and 3 Ton Forklift.
Any other equipment used for these operations will be charged extra on case to case basis.
13. All Import containers are liable to pay container tracking charges of Rs. 450/20 and Rs. 800/40'.
14. For safety and / or operational reasons if ODC cargo is required to be moved on low bed trailer, the movement charges will be quoted on case to case basis.
15. F/R, ODC and Open Top export containers whenever required to be moved under hook for direct loading on the vessel will be charged @ Rs.6500 per container over & above the tariff charge above.
16. It is assumed that all consignments (Import/Export) received at Vaishno Logistic Yard is adequately insured against all possible risk during transportation and storage. VLY assumes No Liability in this respect.
17. The cargo / container receipt / delivery are on Said to Contain and Said to weigh basis.
18. Re-working of containers requiring heavy/special equipment will be decided on case to case basis.
19. CHAs / Consignees intend to pay by cheques must take prior permission from the CFS Management.
20. For weightment purpose if vehicle is provided by party a rebate of Rs. 300/- will be given.
21. Administrative charges of Rs. 400/- per amendment will be imposed on Export/Import/Buffer and self-sealed containers.
22. General space charges, one week is given free from first date of carting. Thereafter Rs. 1000/- per Teus per week will be charged for export cargo.
23. For Back to Town cargo carting charges @ Rs. 90 /MT and loading charges at the same rate will be charged.
24. Detention of vehicles for scanning up to 24 hours: Rs. 2500/- per container for Import containers.
25. Empty Container transportation to PANVEL area empty depot is Rs.1000/TEU extra.
26. Empty container Offloading charges at Depot as actual.
27. Export Mty pick up from yards in Panvel (ERS; BCY; Navkar etc.) Rs. 1000 per container will be charged extra and for yard in Taloja Rs. 2000 per container will be charged extra
28. Import containers are liable to pay a terminal congestion surcharge Rs. 600/- per TEU
29. Import 20 containers from NSICT and GTI Terminals will be charged Rs. 500/- plus Service Tax as Seal Verification charges as charged by these terminals
30. Import containers Facilitation charges Rs. 10000/- per TEU
31. Statutory Risk coverage charges Rs.200/- per container
